ORDERS BY THE GOVERNOR  
NOTIFICATION

Dated, Dispur the 10<sup>th</sup> October' 2017.

No. PEL.129/2015//30 : In exercise of the powers conferred by clause (i) of sub-section (2) of section 180 of the Electricity Act, 2003 (Act No. 36 of 2003), the Governor of Assam is hereby pleased to make the following rules, namely:-

Short title and commencement 1. (1) These rules may be called the Assam Electricity Regulatory Commission (Preparation of Annual Reports) Rules, 2017.  
(2) They shall come into force on the date of their publication in the Official Gazette.

Definitions 2. In these rules, unless the context otherwise requires,-  
(a) "Act" means the Electricity Act, 2003 (Act No. 36 of 2003) ;  
(b) "Schedule" means the Schedule appended to these rules;  
(c) "Year" means a calendar year ;  
(d) Words and expressions used and not defined but defined in the Act shall have the same meanings respectively assigned to them in the Act.

Preparation of Annual Report 3. (1) Every year the State Commission shall prepare an annual report giving/containing a summary of its activities during the previous year commencing from the 1<sup>st</sup> day of April to the 31<sup>st</sup> day of March of the following year in the form specified in the Schedule.  
(2) The Annual Report shall give an account of the activities during the previous financial year, containing inter alia , -  
(a) a statement of goals and objectives of the State Commission ;  
(b) annual targets set for various activities in the background of clause (a) together with a brief review of actual performance with reference to those targets and including in particular a report on the number of cases filed before the State Commission during the previous financial year, number of cases disposed of, time taken to dispose of the cases and number of cases pending ;  
(c) important additions/changes in the regulations of the State Commission ;  
(d) functioning of the State Advisory Committee and other consultation with the stakeholders  
(e) trends of important parameters such as capital cost, cost of electricity, new investment, efficiency gains ;  
(f) number and details of cases in which orders/regulations of the Commission were challenged in Court/Appellate Tribunal and the outcome of such cases ; and  
(g) resolution of disputes including the disputes pending at the end of the previous financial year.

- Submission of Annual Report 4. The copies of the annual report shall be forwarded by the State Commission to the State Government by the end of October each year.
