- Short title and 1. (1) These rules may be called the Assam Electricity (Fees for commencement Making Application for Grant of Licence) Rules, 2017.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- Definition 2. (1) In these rules unless the context otherwise requires,-
 - (a) "Act" means the Electricity Act, 2003 (Central Act No. 36 of 2003);
 - (b) "Section" means a section of the Act;
 - (c) Words and expressions used and not defined in these rules but defined in the Act, shall have the meanings respectively assigned to them in the Act.
- Fees for making application for grant of licence
- 3. (1) Every application made under section 14 of the aforesaid Act for grant of licence by the Assam Electricity Regulatory Commission, shall be accompanied by a fee of Rupees One Lakh only.
 - (2) The fees shall be remitted through demand draft in favour of the Secretary, Assam Electricity Regulatory Commission.
