(2) They shall come into force on the date of their publication in the Official Gazette. |
| Definition | 2. (1) In these rules unless the context otherwise requires,-
(a) "Act" means the Electricity Act, 2003 (Central Act No. 36 of 2003) ;
(b) "Section" means a section of the Act;
(c) Words and expressions used and not defined in these rules but defined in the Act, shall have the meanings respectively assigned to them in the Act. |
| Fees for making application for grant of licence | 3. (1) Every application made under section 14 of the aforesaid Act for grant of licence by the Assam Electricity Regulatory Commission, shall be accompanied by a fee of Rupees One Lakh only.
(2) The fees shall be remitted through demand draft in favour of the Secretary, Assam Electricity Regulatory Commission. |
